This year we had our Ofsted inspection which saw us achieve a good in all areas!



This month, we are taking a dive into the world of finances with Katie, a Finance Manager from a **London Law Firm**

Leaving school at 16, Katie found herself working part time in a pharmaceutical company as an administration assistant, which developed her skills in administration and office duties. After a short time. Katie's role developed to include financial tasks including invoicing and financial duties such as banking.

After 5 years Katie left this role and started a new role in a law firm, as a Legal Biller. This role involved raising invoices for work completed, management of fee earner rates, complex billing, and time recording of queries. This role provided Katie with a progression opportunity where she was able to take on a new role as the collection within the team. Katie also reports to billing and client account supervisor. Within this the CFO for month end, where she spends time role, Katie was responsible for the billing for the firm, as well as the client chasing function. This role also gave Katie line manger responsibilities for a team of 3. Katie was responsible for managing the team to ensure tasks were being completed and the operational drivers of the billing sector were being met. This role supported Katie to develop her management skills which included appraisals, performance management, and overall team performance.

Fast forward 5 years and Katie is now a Finance Manager for a top law firm based in London.

Within this role, Katie has direct line manager responsibilities for a team of five and oversees the day-to-day operations for the revenue control team and cashiering team.

As part of this role, Katie manages projects within the team, which could include introduction of new systems to support the team. Katie also oversees Process change, where she spends time reviewing processes in place and looking at what is working well, and works to implement new processes and procedures to support the function of the team. Another responsibility within Katie's role is meeting targets set for billing and cash looking over reconciliation of financial accounts, bank consolidation, and client reconciliation amongst other tasks.

As part of the role Katie does, she also must follow solicitors account rules, preparations for annual audits, VAT regulations and reporting for fee earners, and following service level agreements within the firm.



We asked Katie

What do you enjoy about your role?

"I enjoy working on projects and driving change within the department. I also enjoy working with my team to help them achieve their potential and progress within their careers."

What advice would you give to a school leaver or someone who is unsure on their career path?

"Think about your options in terms of a career and then make a plan about what you need to do to get to where you want to be"

Strut Safe is a volunteer -operated nonjudgmental support line who you can contact if you are going home alone until you are safe. The organization offer a safe space for individuals and their overall goal is to make sure people get home safely.

You can call strut safe if you are worried about making a journey alone, and the call handler is there to keep you company from travelling from one point to another.

Calls to Sturt Safe are almost always free if you have inclusive minutes within your phone package. Calls to 03 numbers are charged at normal calls rates depending on your mobile provider
